NOTES

Prospective FICPI members should be aware that an attorney (patent or trade mark) no longer needs to be an owner or principal of a firm and membership is also open to Associate memberships. The Annual Conference is also available to first time attendees who are not yet members, but who would like to experience the [many benefits of FICPI membership](#) can access a discount rate and be exempt from paying their membership fee in the first year.

1. Non-member patent and trade marks attorneys who are eligible to apply to become a FICPI member (see Note 3 for eligibility criteria) are invited on a one-time only basis to register and can attend the working session UNLESS membership is approved before the AGM in which case they can attend the AGM as a voting member. Please pass a copy of this registration form to any non-member attorneys you believe may wish to attend on this basis.
2. Eligibility to become an ordinary member of FICPI Australia under Article 5 of the Articles of Association is briefly summarised below; please speak to the Secretary or a Council member if you wish to explore this process further. A prospective member will be a person:
 - in independent practice (eg. see fourth dot point below) as a Patent Attorney in Australia or as a Trade Marks Attorney in Australia
 - have their primary endeavour as a patent attorney or as a trade marks attorney
 - have at least five years' experience as a patent attorney or trade marks attorney since registrations as such in Australia or overseas
 - not practise only on behalf of one client, or an affiliated group of clients, to the exclusion of other clients

Please note that under the amendments made to FICPI Australia Articles of Association, all patent attorneys in private practice for at least five years and trade marks attorneys for a similar period, subject to the additional conditions as specified above, are eligible to become members of FICPI Australia.

3. Eligibility to become an associate member of FICPI Australia under Article 5 of the Articles of Association is briefly summarised below; please speak to the Secretary or a Council member if you wish to explore this process further. Associate members are not able to vote at an AGM or an SGM. A prospective member will be a person:
 - in independent practice (e.g. see fourth dot point below) as a Patent Attorney in Australia or as a Trade Marks Attorney in Australia
 - have their primary endeavour as a patent attorney or as a trade marks attorney
 - not practise only on behalf of one client, or an affiliated group of clients, to the exclusion of other clients
4. Eligibility to become an ordinary member or an associate member of FICPI Australia will also depend on the candidate meeting other requirements and you should discuss all the requirements with the Secretary.
